



## Terms of Agreement

In these terms of agreement for the Hockey Dreams League 2021 (HDF League 2021), the terms and conditions are agreed and recorded between the following parties.

Party 1; Hockey Dreams Foundation, established in Amsterdam, 1076 JR Van Tuyll van Serooskerkenweg 116, legally represented by JWBM Bredius, chairman of the board, and

Party 2; Any party that acts as a sponsor / donor of the HDF league 2021 and associates its name with (part of) this league.

Considering that;

1. Party 1 is a charity foundation with Sport for Development projects in Africa
2. The "Hockey Dreams League" (HDF League) for children will be set up in 2021 in Zambia, Malawi and Uganda as a fundraising event to the foundation
3. The finals of the HDF League, will be held around the finals of the Olympics in Tokyo
4. The ambassadors of Hockey Dreams Foundation - Bjorn Kellerman, Maria Verschoor and Tristan Algera - will be very closely involved in the creation of and throughout the HDF League
5. Parties are being sought for these HDF League as sponsors of one or more teams
6. Party 2 has indicated that it would like to be involved as a sponsor in this League

The parties agree as follows:

- A Party 2 becomes sponsor of the HDF League by;
- Sponsor one or more teams;
  - Sponsor the HDF League;
  - Any other form of sponsorship to HDF
- B Party 2 will receive for this sponsorship (dependable on the sponsor package);
- Kids team named after the company

- Team Shirts with company name / logo
- Several mentions in newsletters, social media posts, company name / logo on website HDF
- Awards in Company name
- After movie
- Clinic by Ambassador

C Parties are mutually authorized to use the name and logo of each other for marketing expressions on the website and social media, insofar as they relate to the HDF League and only in a positive manner.

D Party 1 refers to its [Privacy Policy](#) on its website for the use of (personal) data.

E The League will start in April 2021 and end in August 2021. Finals will be played around the finales of the Olympic Games in Tokyo.

F If due to force majeure (political situation, climatic events, epidemic or other situations) matches cannot be played, this has no financial influence on this sponsorship and will not lead to withdrawal or reimbursement of the sponsorship money to Party 2. Parties will possibly discuss options in good consultation and, if desired, to express this agreement in a different way for the benefit of Party 2.

G By becoming a sponsor of the HDF League, party 2 agrees to this terms of agreement.

Other;

Party 1 is a Non Government Organisation (NGO) with an “ANBI status”, which means that donations and gifts are eligible for deduction for corporate tax.
